



On February 14, a new movie called "VFW" will hit theatres nationwide. The movie's plot is fictitious; a teenage girl runs into a VFW Post's canteen with a bag of stolen drugs. Suddenly under attack from a gang of punk mutants looking to get back what's theirs — at any cost — a group of veterans use every weapon they can put together to protect the girl and their VFW Post.

The VFW agreed to its marks being used in this production based on the agreement that the production would:

- Portray America's veterans as heroic.
- · Emphasize their inherent, enduring commitment to serve.
- Weave a story that positions veterans as resilient, vital and relevant to culture and society.

The movie looks gritty and is very much an "action flick." But the veterans in the movie are portrayed as protectors of the weak ... defenders of those who have suffered injustice ... the good guys. Yes, it's over the top and extreme — but so are movies like Rambo, Die Hard, etc. which position veterans/officers of the law as the heroes. Viewers aren't going into this movie expecting a documentary or a gentle coming of age story. It's billed as science fiction, action and fantasy in review online. Over the top action and scenes are going to be expected. This production has been created for a very niche audience, and thus far, those familiar with the genre like it. VA Gets Big Budget Boost, DoD Gets Small Increase

FRA Director of Legislative Programs John Davis and Assistant Director of Legislative Programs Theo Lawson attended the Department of Veterans Affairs budget briefing on the agency's proposed FY2021 budget. It includes a \$22.6 billion increase (10.2 percent) from the current budget. The proposed budget provides for 14,000 more employees, of which 7,000 are medical staff. The VA anticipates more than 33,000 veterans to enroll in VA healthcare.

The VA budget also provides for \$1.2 billion increase (\$485 million more than 2020) for the Caregiver program, which includes the expansion of the FRA supported program. The budget also includes \$137 million to support the processing of Blue Water Navy disability claims. Since the first week of January, the VA has received 14,000 BWN claims and has paid \$7.5 million in retroactive benefit payments to 218 veterans and their survivors. The VA expects a total of 70,000 BWN claims. The proposed budget provides \$2.6 billion to modernize electronic health records (EHR). The process will provide a seamless transition to the VA for injured or wounded service members.

The DoD budget request for FY21 is consistent with the bipartisan budget agreement Congress passed in 2019. The agency's resources are essentially unchanged from last year's amounts. To compensate, Secretary Esper and our military leaders are implementing reforms and repurposing resources from lower priority functions to programs essential to the National Defense Strategy. The DoD has again requested an 18,000-billet cut in military medical staff.

Deputy VA Secretary Dismissed

Department of Veterans Affairs Secretary Robert Wilkie revealed in a brief statement posted on the VA website, that he terminated his next in command at the VA, Deputy Secretary James Byrne, due to loss of confidence. Byrne was confirmed by the Senate on Sept. 11, 2019 (81-11). He served as acting Deputy Director prior to his Senate confirmation when previous VA Secretary David Shulkin resigned after questions arose about taxpayer-funded travel. Before Byrne served as acting deputy secretary, he served as general counsel for the VA. Before coming to the VA, he served in the Office of the Special Inspector General for Iraq Reconstruction. Earlier, Byrne was a Marine Corps infantry officer.

CCN Payment Delays Discussed at HVAC Joint Subcommittee Meeting

Assistant Director, Legislative Programs Theo Lawson recently attended a joint oversight hearing of the House Veterans' Affairs Subcommittees on Health and Oversight and Investigations. The hearing was about the status of the Community Care Network program provider networks. Attention was paid to the backlog of claims-2.5 million claims out of 3.8 million are older than 30 days. The Department of Veterans Affairs testified that this will be remedied by the end of the fiscal year this September.

The VA is making changes to streamline the payment and referrals process. This includes reforming the purchase and authorization systems and improving effective communication with service providers using technology as opposed to telephone calls. The Community Care Network is responsible for monitoring feedback from the service providers. Currently, 30 percent of veterans obtain health care through CCN.

HVAC Subcommittee Discuss Privacy Concerns at VA

The House Veterans' Affairs Subcommittee on Technology Modernization held a hearing on data privacy for veterans who are using the Department of Veterans Affairs' vendors. The VA explained during the hearing that they have a process for vetting third-party vendors who are part of the Community Care Network. Committee members expressed concern that privacy data should be protected by these third-party vendors. The committee focused on the security of the integrated electronic health record, record sharing and data collection and permissions from apps the VA offers for smartphones. The VA health care information from veterans falls under the jurisdiction of the Health Insurance Portability and Accountability Act (HIPAA) and their personal information falls under the Privacy ACT. A third party vendor must follow VA procedures when gaining access to veteran information. The VA often performs compliance audits to ensure their agreements and policies are upheld. The VA claims that they have policies in place to immediately rectify an incident during a data breach.

The VA Asks for Delay of New Presumptive Conditions Related to Agent Orange Exposure

The Department of Veterans Affairs recently sent a report to the House and Senate Veterans Affairs Committees. It explains their concern with the scientific evidence behind the link between bladder cancer, hypothyroidism, parkinsonism, hypertension and exposure to Agent Orange herbicide. The VA claims that the National Academies of Sciences, Engineering, and Medicine did not identify any "definitive causal links" between Agent Orange and the diseases. The VA is now waiting on the results of its own study. The National Academy of Medicine has already established an association between Agent Orange exposure and these four diseases. The FRA is supporting the Fair Care for Vietnam Veterans Act (H.R.5610), which would increase the presumptive conditions linked to exposure of the Agent Orange herbicide to include parkinsonism, bladder cancer, hypertension and hyperthyroidism. FRA Members are strongly urged to use the FRA Action Center to weigh in on this important legislation.

The FRA has signed onto a letter to President Trump, with several other associations, requesting that he intervene and add these ailments to the list of Agent Orange presumptive conditions for disability benefits immediately.

Select Locations to Offer Virtual Exams for Veterans; ATLAS Provides 'Patient-Centered Care' for Veterans

VA is teaming up with Philips, Veterans of Foreign Wars (VFW), the American Legion and Walmart to provide telehealth services with Project Advancing Telehealth through Local Access Stations (ATLAS). ATLAS allows Veterans to be examined at their local Veterans' service organization post, or Walmart, through virtual appointments with medical professionals across the nation – providing Veterans convenient access to care closer to home.

The sites offer health care services that do not require hands-on exams such as primary care, mental health counseling, clinical pharmacy, nutrition services, social work, and more. It is up to the local VA Medical Center to decide which services to offer.

While there are no VA employees based at ATLAS sites, there is an attendant on-site who will provide Veterans with information, assist them with getting started, troubleshoot any technical issues, and keep the space clean. The attendant will not be present once the appointment begins nor have access to Veterans' medical information. Veterans meet with VA providers through VA Video Connect, VA's secure videoconferencing software. There is no copay for VA Video Connect appointments, whether at an ATLAS site or otherwise. VA providers may prescribe most medications for Veterans during appointments at ATLAS sites.

Veterans interested in this program are encouraged to contact their local VA medical centers to determine service availability in their local area. For more information on VA's telehealth programs, visit www.telehealth.va.gov.

The Blue Water Navy Vietnam Veterans Act of 2019 made changes to the VA Home Loan Program, specifically:

- VA-guaranteed home loans will no longer be limited to the Federal Housing Finance Agency (Federally-established) Confirming Loan Limits. Veterans will now be able to obtain a no-down-payment home loan in all areas, regardless of the loan amount.
- The law exempts Purple Heart recipients currently serving on active duty from the VA Home Loan funding fee.
- VA removed the loan limit for Native American Veterans seeking to build or purchase a home on Federal Trust Land.
- At this time, there is a temporary change to the VA Funding Fee, which is a congressionally mandated fee associated with the VA Home Loan. Veterans and service members will see a slight increase of 0.15 to 0.30% in their funding fee (currently for two years), while National Guard and Reserve members will see a slight decrease in their fee to align with the fee paid by 'Regular Military' borrowers (permanent). Veterans with service-connected disabilities, some surviving spouses, and other potential borrowers are exempt from the VA loan funding fee and will not be impacted by this change.

NEWS: MEDICAL AND MEDICAL BENEFITS

What You Should Know About Coronavirus

The VA is working closely with The Centers for Disease Control and Prevention (CDC) and other federal partners, monitoring an outbreak of Novel Coronavirus (2019-nCoV) first identified in Wuhan, Hubei Province, China. Cases have been identified in the United States and other international locations. This new strain belongs to a group of viruses called coronavirus which can cause symptoms like fever, cough, and shortness of breath.

VA has activated its emergency management coordination cell (EMCC) and is implementing an aggressive and collaborative public health response to protect and care for Veterans. At this time, no Veterans receiving care at VA have been diagnosed with 2019-nCoV. United States is actively screening everyone who has traveled in China for this new disease. Americans who come back from the part of China where the number of infections is very high are required to limit close contact with other people and report changes in their health. VA has been planning for this type of event and is prepared to protect and care for Veterans who receive their health care from VA. What precautions to take

Currently, there is no vaccine to prevent 2019-nCoV infection and no medication to treat it. CDC believes symptoms appear 2 to 14 days after exposure. The best way to prevent infection is to avoid exposure. These basic health measures can reduce the spread of infection.

- Wash your hands often with soap and water for at least 20 seconds. An easy way to mark the time is to hum the "Happy Birthday" song from beginning to end twice while scrubbing.
- Use an alcohol-based hand sanitizer that contains at least 60% alcohol.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- ♦ Stay home when you are sick or becoming sick.
- Cover your cough or sneeze with a tissue (not your hands) and throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces.
- Getting a flu shot is recommended.

What precautions to take when traveling:

The U.S. government has imposed travel restrictions for all non-essential travel to China. Additionally, U.S. citizens returning from the region will undergo enhanced screening procedures. Generally, foreign nationals (other than the immediate family of U.S. citizens, permanent residents, and flight crew) who have traveled in China within 14 days of their arrival, will be denied entry into the U.S. If you have international travel plans, review this specific guidance for travelers.

What to do if you have symptoms:

If you have both symptoms of fever, cough, and shortness of breath and have either recently returned from China or have direct exposure to others diagnosed with 2019-nCoV.

Call before visiting your local VA medical center to seek care. Tell them about your recent travel and your symptoms. To avoid spreading the virus to others, follow the precautions listed above.

NEWS: MILITARY AND LEGISLATIVE

House Passes Puppies Assisting Wounded Servicemembers (PAWS) Act

The House unanimously passed the Puppies Assisting Wounded Servicemembers (PAWS) for Veterans Therapy Act (H.R.4305). It is intended to assist veterans struggling with PTSD and other mental health challenges through service dog training therapy. Committee testimony on the measure noted that mental wellness does not have a one-size-fits-all solution, which is why the VA must provide innovative and out-of-the-box treatments to help veterans combat these invisible illnesses. There is no question that the companion-ship and unconditional love offered by man's best friend can have powerful healing effects on men and women from all walks of life, including our men and women in uniform. The bill now goes to the Senate for further consideration.

President Signed Bill to Enhance STEM Careers for Veterans and Military Spouses

President Trump signed into law the Supporting Veterans in STEM Careers Act (S.153), which was sponsored by Sen. Marco Rubio (Fla). The act will assist veterans who are re-entering the workforce by directing the National Science Foundation to encourage veterans to pursue careers in science, technology, engineering and math (STEM). The act mandates the NSF's Office of Science and Technology to establish an interagency working group to increase veteran and military spouse representation in the STEM field.
